3. The learned Additional Government Pleader submitted that there are two rival groups and therefore, the petitioner may be directed to appear before the respondent No.2/Inspector of Police.

4. The learned Counsel for the petitioner submitted that the matter has been compromised.

Be that as it may, considering the submission made by the learned Additional Government Pleader, the petitioner is directed to appear before the second respondent-Inspector of police on 04.05.2015. It is open for the second respondent to call other parties, who are required and imposed any conditions to grant permission to conduct festival and the cultural programme.

6. Accordingly, the Writ Petition is disposed of. No costs.
