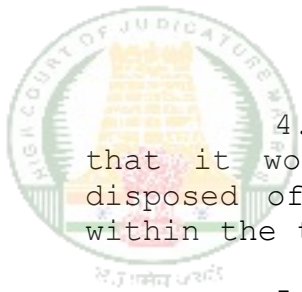

ORDER

In view of the above, without going into the merits of the claim made by the petitioner in this Writ Petition, the first respondent is directed to pass appropriate orders on the representation of the petitioner, dated 13.03.2015, on merits and in accordance with law, after giving notice to the interested parties, if any, within a period of three weeks from the date of receipt of a copy of this order.

With the above direction, this Writ Petition stands disposed of.
