O R D E R

This Writ Petition has been filed seeking for the issuance of Writ of Mandamus, directing the third respondent to give Police protection and necessary permission for conducting the temple festival for Arulmighu Sri Muppudathi Amman Temple Bramadesam Village, Ambasamudram Taluk, Tirunelveli District to be held on 11/5/2015 and 12/5/2015.

2. Heard the learned counsel appearing for the petitioner and the learned Additional Government Pleader appearing for the respondents.

3. Mr.R.Karthikeyan, learned Additional Government Pleader appearing for the respondents, on instructions, would submit that totally two groups are involved, in that, one belong to the petitioner and another is the third party. The permission sought for by the petitioner may be granted with stringent conditions for maintaining law and order



and also to avoid any untoward incident during performance of such programme.

4. Considering the facts and circumstances, this Court is not inclined to grant relief, but, however, the petitioner is directed to appear before the third respondent Police within a period of one week from the date of receipt of the copy of this order. The respondents can also call the other group and seek assistance of the Tahsildar by convening a Peace Committee Meeting. If any settlement is arrived at, then appropriate permission can be given, subject to the conditions that can be imposed.

5. With the above direction, the Writ Petition is disposed of. No costs.
