ORDER

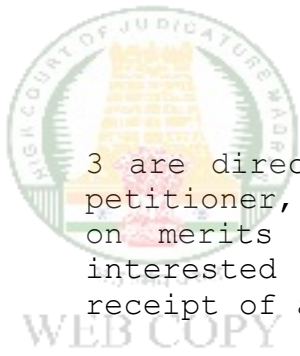
The petitioner has come forward with this Writ Petition to consider the representation of the petitioner dated 28.01.2015.
