On notice to the learned Govt.Advocate, he produced a copy of the proceedings made in Na.Ka.No.1783/2015, A3 dated 03.06.2015 stating that the parties have been directed to appear for an enquiry on 24.06.2015 for conducting the survey of the lands in question. The submission as well as the proceedings are recorded.
