Heard the learned counsel appearing for the petitioner and Mr.V.Muruganandam, learned Additional Government Pleader who takes notice on behalf of the respondents. By consent, the writ petition itself is taken up for final disposal at the admission stage.

2.The prayer in the writ petition is to direct the first respondent to pass an order transferring the petitioner to the Government High School, Ezhagaram in Kanyakumari District or any one of the vacancy available in Kanyakumari District as High School Headmistress by considering the representations of the petitioner dated 13.04.2015 in the light of G.O.Ms.No.137 (School Education) Department dated 09.06.2014.

3.On instructions, learned Additional Government Pleader submitted that till date no Government Order has been issued for counselling to be conducted for transfer and during the course of counselling, the case of the petitioner will be considered, if she is found eligible.
