3. On instructions, learned Additional Government Pleader submitted that till date no Government Order has been issued for counselling to be conducted for transfer and during the course of counselling, the case of the petitioner will be considered, if he is found eligible.

4. In the light of the above, the writ petition is disposed of directing the respondents to consider the petitioner's representation dated 30.04.2015 at the time of counselling and pass appropriate orders. No costs.
