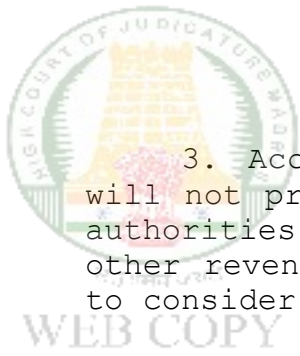
COMMON PRAYER: Writ Petitions are filed under Article 226 of the Constitution of India to issue a Writ of Mandamus directing the respondents to consider the petitioners' representation dated 03.05.2015 and consequently to survey the petitioner's land by fixing the boundary and to grant individual patta to the petitioners' land situated in Survey No. 450 total extent of 6 Acres at Thangamalpura, Mailadumpara revenue Village, Andipatti Taluk, Theni District; S.Nos.484/7A, 484/8A at Thummakundu, Megamalai Village, Andipatti Taluk, Theni District and S.Nos.683/3, 683/7, 501/7, 506/3, 513/2, 513/7, 513/1, 513/5 at Valipara, Megamalai Village, Andipatti Taluk, Theni District respectively.
