Prayer: This Writ Petition has been filed under Article 226 of the Constitution of India praying for a Writ of Mandamus directing the respondents to consider the petitioner's application and pass appropriate orders granting patta to him in respect of his Shop No.171-A, bearing Survey No.545/1 an extent of 247 sq. ft. South Street, Thiruvaiyaru, Thanjavur District and consider his representation, dated 11.02.2015 within the time frame that may be stipulated by this Court.

ORDER

The Writ Petition has been filed by the petitioner praying for a Writ of Mandamus directing the respondents to consider the petitioner's application and pass appropriate orders granting patta to him in respect of his Shop No.171-A, bearing Survey No.545/1 measuring to an extent of 247 sq. ft. situated at South Street, Thiruvaiyaru, Thanjavur District and consider his representation, dated 11.02.2015 within a stipulated time.

2. Mr. S. Kumar, learned Additional Government Pleader takes notice for the respondents.



3. By consent, the Writ Petition itself is taken up for final disposal.

4. It is averred in the petition that the petitioner is having shop No.171-A situated in survey No.545/1 measuring to an extent of 247 sq. ft. at South Street, Thiruvaiyaru, Thanjavur District. The said property originally belonged to one Thamira Selvai and Sivaraman. Thereafter, the petitioner had purchased the property from the said Thamira Selvi on 23.12.1996. From the said date onwards, the petitioner is in possession and enjoyment of the above said property. While so, the petitioner had applied for issuance of patta before the respondents along with all the relevant documents. He had also made representation to the respondents on 11.02.2015. But there was no response. Hence, the petitioner has come forward with the present Writ Petition for the above stated relief.

5. Considering the submissions made by the learned counsel for the petitioner, without going into the merits of the averments made in the Writ Petition, this Court directs the petitioner to give a copy of the representation, dated 11.02.2015, to the third respondent, along with a copy of this order, within a period of one week from the date of receipt of a copy of this order and on receipt of the same, the third respondent is directed to consider the same and pass appropriate orders, in accordance with law after affording an opportunity of hearing to the petitioner as well as to all the necessary parties, with regard to issuance of patta, within a period of six weeks thereafter.

With the above direction, the Writ Petition is disposed of. No Costs.
