ORDER

When the matter is taken up for hearing, the learned counsel appearing for parties represented that since the matter is in PRC stage, the learned District Munsif Cum Judicial Magistrate, Andipatti, Theni District may be directed to complete the proceedings within a time frame as may be fixed by this Court.
