3. The petitioner made a copy application seeking issuance of the orders passed in the following cases:-

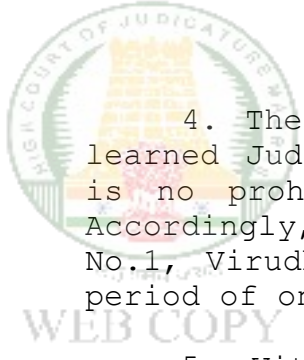
