JUDGMENT

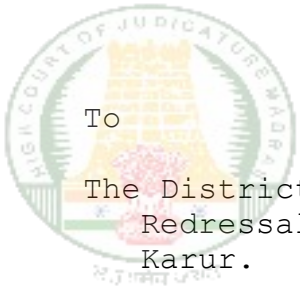
(Judgment of the Court was delivered by V.RAMASUBRAMANIAN,J)
