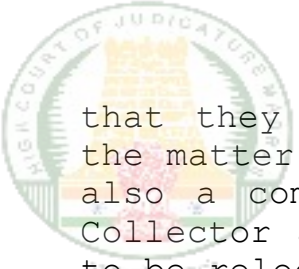

This writ petition has been filed in public interest, seeking a Writ of Mandamus, to direct the respondents to close the TASMAC shop No.5561 situated near Pandikovil, Ring Road, Madurai.

2. We have faith in the District Collectors. We find



that they consider the objections raised by people concerned in the matter of location or relocation of TASMAL shops. In this case also a complaint is made. It may be considered by the District Collector and if any violation is found, the shop may be directed to be relocated to an appropriate place.

3. With the above observation, this writ petition stands disposed of. No costs. Connected Miscellaneous Petition is closed.
