PRAYER: The Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus, calling for the records relating to the impugned order of the respondent in Ref.No.286/ROCH/PCOS/227823/2010, dated 24.03.2010 and quash the same and consequently, direct the respondents to disburse the terminal benefits of the petitioner along with reasonable interest.

ORDER

(Order of this Court was made by THE HON'BLE CHIEF JUSTICE)

The petitioner is aggrieved by the non-release of his terminal benefits by the first respondent/Bank, based on the plea that the issue of validity of the community certificate issued to the petitioner was in question and a finding was arrived at against the petitioner.



2.Learned counsel for the petitioner states that subsequently, through a judicial verdict, the matter was remitted back for consideration by the second respondent/Committee and it is only recently, vide order dated 20.03.2015, the petitioner has succeeded in establishing his status as a member of the Scheduled Tribe Community. A copy of this order has been produced in Court and handed over to the learned counsel for the first respondent/Bank.

3.In view of the aforesaid, learned counsel for the first respondent/Bank submits that the matter would be revisited and a decision, in accordance with law, would be taken within a maximum period of two months from today subject to the petitioner producing the Original Certificate

4.Petition is disposed of, in terms aforesaid. No order as to costs. Consequently, connected M.P. is closed.
