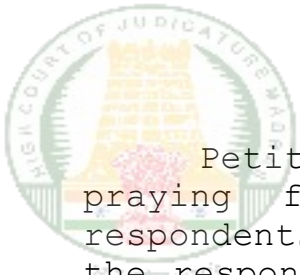

Petition filed under Article 226 of the Constitution of India praying for issuance of a Writ of Mandamus, directing the respondents 1 to 3 to consider and take appropriate action against the respondents 5 to 7 for their malpractice and misappropriation committed on Tamil Nadu Government allotted fund of Rs.23 54 700/- for the period 2011-2012 in SDI-Modular Employment Skill Course Scheme and further direct the 9th Respondent to take appropriate criminal action against the Respondents 5 to 8 by booking them under relevant penal section of 354, 447, 509, 506(i) of IPC read with Tamil Nadu Prohibition of Harassment of Women Act and Prevention of Atrocities against Scheduled Caste and Scheduled Tribes Act and to further direct the 7th and 8th respondents not to make any hindrance in any form for the continuance and completion of Higher Secondary Course by the 11th respondent based on the petitioner's representation dated 27.07.2012.
