In view of the above, without going into the merits of the claim made by the petitioner in this Writ Petition, the third respondent is directed to consider the representation of the petitioner, dated 17.01.2013, on merits and in accordance with law, after giving notice to the interested parties, if any, within a period of six weeks from the date of receipt of a copy of this order.

With the above direction, this Writ Petition stands disposed of. No costs.
