Considering the fact that the petitioner has given a representation on 14.09.2013 and so far the respondents have not filed any objection, this Court directs the second respondent to consider the representation of the petitioner dated 14.09.2013 and pass orders on the same on merits and in accordance with law within a period of one week from the date of receipt of a copy of this order.

6. With the above directions, this writ petition is disposed of. Consequently the connected Miscellaneous petition is closed. No costs.
