Therefore, he has given representation to the first respondent on 09.10.2013, to take action against the respondents 2 and 3 and conduct an enquiry, based on the representation of the petitioner.



3. The learned counsel appearing for the first respondent submitted that the term of the respondents 2 and 3 is already over and now, they are not office bearers of Jamath.
