2.It is seen that the petitioner has given a representation dated 07.05.2013 to the first respondent for the above said relief. Since no order has been passed, the present writ petition has been filed.

3.We do not express any opinion on the merits of the representation of the petitioner dated 07.05.2013 except to direct the concerned respondent to consider and dispose of the said representation on its own merits and in accordance with law.

4.With the above observation, the writ petition stands disposed of. No costs. Consequently, M.P(MD)No.1 of 2013 is closed.
