Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the Affidavit filed herein the High Court may be pleased to issue a direction, order or writ more particularly one in the nature of writ of Mandamus declaring the action of the 1st respondent in rejecting the appeal filed by the petitioner vide order dated 26-11-2009, confirming the orders passed by the 2nd respondent vide proceedings F.SRO/NCTE/Ref/2008-09/5866 dated 6-10-2008 as arbitrary, illegal and contrary to the provisions of NCTE Act and consequently set aside the same;

ORDER: Post after Sankranthi Vacation, 2010.

There shall be interim suspension of the impugned order dated 26-11-2009 passed by 1st respondent in rejecting the appeal filed by the petitioner confirming the orders passed by the 2nd respondent vide proceedings F.SRO/NCTE/Ref/2008-09/5866 dated 6-10-2008. However, it is directed that the petitioner shall be entitled to run the B.Ed. College in the next academic year, only after the premises in which the college is to be located is approved by the competent authority.
