

THE HON'BLE SRI JUSTICE T.SUNIL CHOWDARY

Crl.P.M.P.Nos.13687, 13688 & 13689 of 2015

AND

CRIMINAL PETITION No.13772 of 2015

COMMON ORDER:

1 This criminal petition is filed under Section 482 of Cr.P.C to quash the proceedings against the petitioners / A.1 to A.4 in C.C.No.24 of 2013 on the file of the Court of the III Additional Chief Metropolitan Magistrate, Hyderabad, registered for the offences punishable under Sections 498-A of IPC and Sections 3 and 4 of Dowry Prohibition Act.

2. Crl.P.M.P.No.13687 of 2015 is filed to permit the 2nd petitioner to represent the first petitioner as his General Power of Attorney also permit Sri K. Rathangapani Reddy the learned counsel on record for the petitioners to represent the 4th petitioner as his GPA holder. Crl.P.M.P.No.13688 and 13689 of 2015 are filed to permit second respondent—*de facto* complainant to compromise the matter with the petitioners/A.1 to A.4

3. The GPA holder of the first petitioner i.e. second petitioner herein, the third petitioner and the second respondent are present. Sri K.Rathangapani Reddy, learned counsel identified the petitioners. Mr. Pavan Kumar Pujari, learned counsel identified the second respondent.

4. The second respondent submitted that she voluntarily entered into compromise with the petitioners. She further submitted that nobody compelled or forced her to enter into compromise with the petitioners. The offence under Section 498-A of IPC is compoundable with the permission of the Court, whereas the offence under Sections 3 and 4 of Dowry Prohibition Act are non-compoundable.

5. In **Shiji alias Pappu v Radhika**, the Supreme Court held as under:

“It is manifest that simply because an offence is not compoundable under Section 320 CrPC is by itself no reason for the High Court to refuse exercise of its power under Section 482 CrPC. That power can in our opinion be exercised in cases where there is no chance of recording a conviction against the accused and the entire exercise of a trial is destined to be an exercise in futility. There is a subtle distinction between compounding of offences by the

parties before the trial court or in appeal on the one hand and the exercise of power by the High Court to quash the prosecution under Section 482 CrPC on the other. While a court trying an accused or hearing an appeal against conviction, may not be competent to permit compounding of an offence based on a settlement arrived at between the parties in cases where the offences are not compoundable under Section 320, the High Court may quash the prosecution even in cases where the offences with which the accused stand charged are non-compoundable. The inherent powers of the High Court under Section 482 CrPC are not for that purpose controlled by Section 320 CrPC.”

6. In **Gian Singh v State of Punjab**, the apex Court observed as under:

“..... In this category of cases, High Court may quash criminal proceedings if in its view, because of the compromise between the offender and victim, the possibility of conviction is remote and bleak and continuation of criminal case would put accused to great oppression and prejudice and extreme injustice would be caused to him by not quashing the criminal case despite full and complete settlement and compromise with the victim. In other words, the High Court must consider whether it would be unfair or contrary to the interest of justice to continue with the criminal proceeding or continuation of the criminal proceeding would tantamount to abuse of process of law despite settlement and compromise between the victim and wrongdoer and whether to secure the ends of justice, it is appropriate that criminal case is put to an end and if the answer to the above question(s) is in affirmative, the High Court shall be well within its jurisdiction to quash the criminal proceeding.”

7. Taking into consideration the factum of settlement arrived at between the parties, this Court is of the view that even if the proceedings are allowed to continue, the second respondent may not support the case of the prosecution. No purpose will be served in keeping the matter pending in view of the settlement arrived at between the parties.

8. Having regard to the facts and circumstances of the case and also the principle enunciated in the cases cited supra, I am of the considered opinion that it is a fit case to quash the proceedings.

9. In the result, CrI.P.M.P.No.13687 of 2015, CrI.P.M.P.No.13688 and 13689 of 2015 are ordered. Consequently, the Criminal Petition is allowed, quashing the proceedings against the petitioners/A.1 to A.4 in C.C.No.24 of 2013 on the file of the Court of the III Additional Chief Metropolitan Magistrate, Hyderabad. Miscellaneous petitions, if any pending in the Criminal Petition, shall stand closed.
