Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed herein, the High Court may be pleased to issue an appropriate writ, order or direction more particularly one in the nature of Mandamus declaring the action of the 2nd respondent in dismissing the appeal filed by the petitioner for the assessment year 2010-11 under APVAT Act 2005 through the impugned proceedings Dt. 29-10-2014 while upholding the levy of purchase tax by the 1st respondent on the turnover of cotton de oiled cake dispatched to other States on consignment transfers invoking power under Section 4(4) of the AP VAT Act, and set aside the same and consequently set aside order of the 1st respondent Dt.30-3-2013 in Form 305 against which the petitioner filed appeal before the 2nd respondent.
