Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed herein, the High Court may be pleased to issue an appropriate writ order or direction more particularly one in the nature of writ of mandamus by declaring the action of the respondents in transferring the petitioner outside the Sub-Division vide Memo No. DEE/OP/MBD/JAO(Adm)/SA1/D.No.394/2015 dated 30.5.2015 contrary to the transfer guidelines communicated vide Memo No. MD(CGM(HRD)./ GM(S)/AS(Estt)/PO.A/261-A3/15, dated 11.5.2015 as being arbitrary, illegal, discriminatory, motivated and in violation of Articles 14 of the Constitution of India and consequently hold that the petitioner shall be transferred or retained in Thorrur sub -Division with all consequential benefits .
