

THE HON'BLE SRI JUSTICE T.SUNIL CHOWDARY

CRIMINAL PETITION No.13967 of 2015

ORDER:

This petition is filed under Section 482 Cr.P.C. to quash the proceedings against the petitioners/A.1 to A.5 in Crime No.220 of 2015 on the file of the Station House Officer, Ghanpur Mulug Police Station, Warangal District, registered for the offences under Sections 120B, 447, 448, 324, 430 and 506 read with 34 I.P.C.

2. Heard the learned counsel for the petitioners and the learned Public Prosecutor representing the State.

3. A perusal of the record reveals that the petitioners are accused Nos.1 to 5 and the second respondent is the *de facto* complainant in Crime No.220 of 2015.

4. As per the allegations made in the complaint, the second respondent has been in possession and enjoyment of an extent of Ac.14.02 guntas of land in Survey No.1 of Karkapalli Village, Ghanpur Mandal, Warangal District. It is further alleged that on 23.06.2015, the petitioners formed into an unlawful assembly and trespassed into the land of the second respondent. It is also alleged that the petitioners threatened the second respondent with dire consequences.

5. A perusal of the record reveals that civil disputes are pending between the parties with regard to the above said land. It further reveals that S.A.No.1339 of 2003 is pending before this Court. Whether the petitioners have committed the alleged offences or not will come to light during the course of investigation.

6. While exercising the inherent power under Section 482 Cr.P.C., the Court has to take into consideration the allegations made in the complaint only. The Court is not justified in embarking upon an enquiry as to probability, reliability or genuineness of the allegations

made in the complaint at the initial stage of investigation. The material placed before the Court is *prima facie* sufficient to investigate into the matter in order to ascertain the truthfulness or otherwise of the allegations made in the complaint.

7. Having regard to the facts and circumstances of the case and also the principles enunciated by the Supreme Court in **R.P.Kapoor v. State of Punjab**^[1] and **State of Haryana v. Bhajanlal**^[2], I am of the considered view that it is not a fit case to quash the proceedings at the initial stage of the investigation.

8. The learned counsel for the petitioners submitted that the concerned Station House Officer may be directed not to arrest the petitioners till completion of the investigation.

9. Taking into consideration the facts and circumstances of the case, this Court is inclined to direct the Station House Officer, Ghanpur Mulug Police Station, Warangal District, not to arrest the petitioners/A.1 to A.5 in Crime No.220 of 2015 till completion of the investigation.

10. With the above direction, the Criminal Petition is dismissed.

11. Consequently, Miscellaneous Petitions, if any, pending in this Criminal Petition shall stand closed.
