Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed herein, the High Court may be pleased to issue

- (i) issue a writ, order or direction more particularly one in the nature of CERTIORARI declaring the impugned revision order passed under the Andhra Pradesh Entertainment Tax Act, 1939 by the 1st respondent (for the Q.E. 30-09-2008) vide RV No.LV(4)/29/2013, dated 14-11-2014 restoring the order passed by the 3rd respondent without disclosing the material on the basis of which assessment was made and without affording personal hearing though it was specifically asked for as contrary to principles of natural justice, and without jurisdiction in as much as 1st respondent is not vested with any power of revision u/s 9C of the Act contrary to sections 9, 9C, 15-A, rule 39, G.O.Ms.No.1644, dated 8-11-2006, Articles 14, 265 & 300-A as illegal & arbitrary and quash the same;
- ii) Issue a writ, order or direction quashing the consequential order and demand notice passed by the 3rd respondent vide Form 'A' dated 24-11-2014;
- iii) Alternative Relief: In case the jurisdictional plea is rejected the petitioner may be

permitted to convert this writ petition into appeal u/s 9-E of the APET Act, 1939 read with rule 44 of the APET Rules, 1939;
