The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and the order of the High Court dated: 09.07.2015 and upon hearing the arguments of Sri Kuna Reddy Anji Reddy, Advocate for the Petitioner and GP for Social Welfare (TG) for Respondent Nos.1 to 3, the Court made the following
