Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed herein, the High Court may be pleased to issue a writ or order or direction, especially one in the nature of Writ of Mandamus: i) declare the action of the respondents in not earmarking 25% of posts of Management Trainee (Mining) in E2 Grade, in the employment notification No.1/2015 issued by the 1st respondent as illegal and arbitrary ii) consequently direct the respondents to consider petitioners' names under 25% quota as per the merit of internal candidates is concerned and appoint the petitioners as per their merit amongst the internal candidates as Management Trainee (Mining).
