Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed herein, the High Court may be pleased to pass an order or writ more particularly in the nature of Writ of Mandamus, by duly declaring the action of the second respondent in issuing the notice U/s 636 of GHMC Act, when our applications under GO Ms.No.58 is pending consideration with the revenue department, in respect of H.No.2-2/A, at Gopanapalli Village, Serilingampalli Mandal, Ranga Reddy District, bounded by North: Road, South, West and East the part of survey number 35, and consequently struck down the notice No.111/US/WN/CIR-11/WZ/GHMC, dated 18th June, 2015 direct the second and third respondent not to dispossess and not to dismantle the above said house in the interest of justice.
