Since the police have already investigated and filed a
charge sheet and as that petitioner is in jail from 16-11-2014, I
am inclined to grant bail to the petitioner on certain terms and
conditions.

Accordingly, the Criminal Petition is allowed. The petitioner
shall be released on bail on his executing a bond for Rs. 5,000/-
(Rupees five thousand only) with two sureties for a like sum
each to the satisfaction of the XXIV Metropolitan Magistrate,
Kukatpally at Miyapur.

As a sequel thereto, Miscellaneous Petitions, if any, pending shall stand closed.
