“Learned counsel for the petitioner submits that his appeal before the Deputy Commissioner was rejected on 18.03.2015 and that petitioner has already filed appeal before the Commissioner of Prohibition and Excise along with the stay petition on 19.03.2015.

Learned Government Pleader, who takes notice for respondents, states that the appeal shall be heard and disposed of by 30.03.2015.

In view of that, if any auction is conducted as per the impugned order, the same shall not be finalized till 30.03.2015.
