No. PP. II(1)2085 / 2005, dt.21-01-2006 and consequential letter NO.PPI1(1)2085/2005, dated 21-01-2006 as illegal, arbitrary, unconstitutional and without jurisdiction and further direct the Respondent not to interfere with in any manner with the bio-products of the Petitioner including from the licensed premises of its dealers/stockiest under the Insecticides Act, 1968 and the Fertilizers Control (Order) Act 1985.;
