Petition under sections 437 & 439 of Cr.PC., praying that in the circumstances stated in the memo of grounds filed herein, the High Court may be pleased to enlarge the petitioner on bail in Crime No.158/2015 Gajuwaka P.S., Visakhapatnam.

The petition coming on for hearing, upon perusing the Petition and the memo of grounds filed herein, and upon hearing the arguments of Sri S. APPADHARA REDDY Advocate for the Petitioner, and of Public Prosecutor (AP) for Respondent, the Court made the following.

ORDER:

This criminal petition is filed by the petitioner, under sections 437 and 439 Cr.P.C., seeking bail in Crime No.158 of 2015 of Gajuwaka P.S., Visakhapatnam, registered for the offences punishable under Sections 302 and 201 I.P.C.

The case of the prosecution is that the petitioner, who is the son of the deceased mother, is in love with a girl and wants to marry her, but the same was not accepted by the deceased and in the oral altercation between the petitioner and his deceased mother, the

petitioner thrown his mother on the floor, by which she sustained injury and died.

Heard the learned counsel for the petitioner and the learned Additional Public Prosecutor.

The petitioner was sent to judicial custody on 24-03-2015. Nearly for the last 71 days the petitioner has been in prison. The investigation is also likely to be completed.

Considering these circumstances, this Court is inclined to grant bail to the petitioner.

Accordingly, the criminal petition is allowed and the petitioner/accused shall be enlarged on bail on his executing a personal bond for Rs.10,000/- (Rupees Ten thousand only) with two sureties for the like sum each to the satisfaction of the III Additional Chief Metropolitan Magistrate, Visakhapatnam and the petitioner shall report before the S.H.O. concerned daily for a period of 15 days.
