ARUN PALLI J. (Oral)

Having argued the matter at some length, learned counsel for the petitioner fairly submits that the petitioner be only afforded nine months' time to vacate the demised premises, as he does not wish to press the petition on merits.

Notice of motion.

Mr. SK Jain, Advocate, who is present in court on behalf of the caveators-respondents, accepts notice and submits that he does not oppose the prayer that has been advanced by learned counsel for the petitioner and let nine months' time be granted to the petitioner-tenant to vacate the demised premises.

Caveat is discharged.

That being so, the petition is disposed of in the following terms:

i) petitioner-tenant shall continue to occupy the demised premises for a period of nine months from today i.e. upto 13.07.2016;

ii) the entire arrears of rent, if any, shall be paid by the petitioner-tenant to the respondent-landlord within four weeks from today, failing which respondent-landlord shall be free to execute the order of eviction;

iii) petitioner shall continue to pay the future rent/mesne profits by 7th of every month to the respondent-landlord. In the event of even a single default, respondent-landlord shall be at liberty to execute the order of eviction forthwith;

iv) petitioner shall defray all the water/electricity charges for the period he would occupy the demised premises;

v) petitioner shall vacate the demised premises and hand-over its actual physical and vacant possession, free from all encumbrances to the respondent-landlord, on or before the stipulated date i.e. 13.07.2016, failing which respondent-landlord shall be free to execute the order of eviction and obtain possession; and

vi) petitioner shall furnish an undertaking in the above terms, by way of an affidavit, within two weeks from

today, before the executing court, failing which again respondent-landlord shall be at liberty to execute the order of eviction.
