This petition under Section 438 Cr.P.C. has been filed by the petitioner seeking anticipatory bail in FIR No. 22 dated 04.08.2010 registered under Sections 380/411 of the Indian Penal Code at Police Station Garhdiwala, District Hoshiarpur.

When this case was listed on 06.01.2015, following order was passed:-

“Notice of motion for 10.03.2015.

In the meantime, the petitioner shall appear before the trial Court and submit his bail/surety bonds, which shall be accepted by the trial Court to its satisfaction.”

On instructions from HC Davinder Singh, learned State counsel submits that in terms of the above-stated order dated 06.01.2015, the petitioner has appeared before the trial Court and furnished the bail

bonds.

In view of the above and without expressing any opinion on merits of the case, the instant petition is allowed and the order dated 06.01.2015 is made absolute and the bail bonds furnished by petitioner before the trial Court would continue during the pendency of the trial, subject to the condition that the petitioner would keep on appearing before the trial Court on each and every date that may be fixed by the trial Court, failing which the trial Court is at liberty to cancel his bail.
