Prayer made in the present petition filed under Section 438 Cr.P.C. is for grant of anticipatory bail to the petitioner in Criminal Complaint No.1999/2013, Case No. COMI-1196/2013, dated 15.01.2010, titled as “Monika Gupta Vs. Sadhu Ram and others”, under Sections 409/420/467/468/471/406/120-B/323/506 IPC, registered at Police Station City, Bhiwani District Bhiwani.

On 03.08.2015, this Court ordered the present case to be heard along with *Crl. Misc. No. M-14218 of 2015*, titled as “Rajender and another Vs. State of Haryana and another”. On 06.08.2015, this Court in *Crl. Misc. No. M-14218 of 2015* had directed the counsel for

the petitioners to file an affidavit of the petitioners showing the details that they are facing prosecution in as to how many cases.

Pursuant thereto, learned counsel for the petitioner has placed on record the affidavit of Sadhu Ram in Court today, the same is taken on record. As per the affidavit, six cases are pending against the petitioner, the details of cases reads as under:-

“(A) State Versus Sadhu Ram & other, bearing FIR No.315, under Section : 406, 409, 420, 506 & 120 B IPC, Police Station City Bhiwani.

(B) Seema Versus Sadhu Ram & other, a Complaint case under Section : 323, 420, 506 & 120 B IPC, Police Station City Bhiwani.

(C) L.N. Dahiya Versus Sadhu Ram & other, a Complaint case under Section : 406, 409, 420, 467, 468, 471, 323, 506 & 120 B IPC, Police Station City Bhiwani.

(D) Satbir Versus Sadhu Ram & other, a Complaint case under Section : 406, 409, 420, 467, 468, 471, 323, 506 & 120 B IPC, Police Station City Bhiwani.

(E) Monika Versus Sadhu Ram & other, a Complaint case under Section : 406, 409, 420, 467, 468, 471, 323, 506 & 120 B IPC, Police Station City Bhiwani.

(F) Anil Talwar Versus Sadhu Ram, a Complaint case under Section : 138 N.I Act”.

Taking into consideration the fact that the petitioner is involved in as many as six cases of similar nature, no ground for grant of anticipatory bail is made out.

Dismissed.
