Prayer in this petition filed under Section 482 CrPC is for transfer of investigation of case FIR No.41 dated 18.2.2014 under Sections 376D/506/34 IPC registered at Police Station Ferozepur Jhirka, District Mewat to some independent agency.

This Court, on February 12, 2015, had passed the following order:-

*“Learned counsel for the petitioner contends that
the statement of victim's mother who rescued the victim*

from the custody of respondents No.4 and 5 was not recorded. The father of the victim has fully supported the version rendered in the FIR. The police officials in connivance with the respondents have prepared a cancellation report on the basis of attendance register, mobile call locations and FSL report. The investigation was carried out by Inspector Dalbir Singh. In the interest of justice, it is ordered that the further investigation be conducted in the matter after associating all the necessary parties including the mother of the prosecutrix under the supervision of Superintendent of Police, Mewat.

Post again on 21.04.2015.”

Pursuant to the aforesaid order, learned State counsel has filed the status report by way of affidavit of Yad Ram, HPS, DSP, Ferozepur Jhirka in Court, which is taken on record. In the said report, it is submitted that the facts of the case were verified by Satish Balan, IPS, Superintendent of Police, Mewat and accordingly, a Special Investigation Team (SIT) was constituted by him. The team was directed to investigate the case under the supervision of DSP, Ferozepur Jhirka. Accordingly, the witness - Hassan Mohd. joined investigation, who has categorically stated that he was not a witness in the incident. The statement of Jubeda, who is mother of the prosecutrix, was also recorded and it is on the aforesaid basis, the investigation has been conducted by the SIT.

Considering the fact that the police has conducted further

investigation and facts were verified by the Superintendent of Police,
no further indulgence of this Court is required in the present petition.

Accordingly, the petition is disposed of.
