JASWANT SINGH, J. (ORAL)

Present petition, under Section 482 Cr.P.C., is for quashing the cross case against the petitioners in FIR No. 166, dated 31.12.2001 (**Annexure P-1**) for offences punishable under Sections 326, 324, 323, 452 and 34 of the Indian Penal Code, registered at Police Station Kathunangal, Tehsil and District Amritsar, as also setting aside the judgment/order dated 16.12.2011 (**Annexure P-2**), passed by the Judicial Magistrate First Class, Amritsar, whereby the petitioners/accused as well as the complainant party have been convicted and subsequent proceedings arising therefrom on the basis of compromise dated 17.05.2014 (**Annexure P-3**) arrived at between the parties.

As per allegations, on 29.12.2001 at about 9/9.30 a.m., when Tasvir Singh (respondent No. 4) came from Amritsar and alighted from the bus, then accused/petitioner Nos. 1 and 3 caught hold him from hair and after hearing the noise, Balkar Singh and Rajwant Kaur (respondent No. 2 and 3 respectively herein) came there to rescue Tasvir Singh. Then, accused/petitioners armed with *kirpan*

and *datar*, respectively, waylaid the complainant/Balkar Singh and inflicted several injuries on the person of complainant party, because of the land dispute, prior to the incident.

Vide order dated 10.09.2015, this Court directed the learned Illaqa Magistrate/trial Court to send report with regard to compromise in pursuance of which, a report/letter No. 378 dated 16.10.2015 has been received from the learned Additional Sessions Judge, Amritsar, which is taken on record as **Mark-A**. It is stated in the report that the complainants have arrived at a compromise with the accused-petitioners without any undue influence and pressure.

Hon'ble Supreme Court in **(2003) 4 SCC 675, B.S Joshi & Others Vs. State of Haryana & Another** has made it explicitly clear in para 15 of its judgment that the High Court in exercise of its inherent powers can quash criminal proceedings or FIR or complaint and Section 320 of the Code does not limit or effect the powers under Section 482 of the Code.

A Full Bench of this Court in **Kulwinder Singh and others v. State of Punjab and another, 2007(3) RCR (Criminal) 1052** has held that this Court, in appropriate cases, while exercising powers under Section 482 Cr.P.C., may quash an FIR disclosing the commission of non compoundable offences. The relevant extracts read as under:-

“ The only inevitable conclusion from the above discussion is that there is no statutory bar under the Cr.P.C., which can affect the inherent power of this Court under Section 482. Further, the same cannot be limited to matrimonial cases alone and the Court has the wide power to quash the proceedings even in non-compoundable offences notwithstanding the bar under Section 320 of the Cr.P.C., in order to prevent the abuse of law and to secure the ends of justice. ”

Hon'ble Apex Court in another case in **J.T 2008(9) S.C 192, Nikhil Merchant Vs. Central Bureau of Investigation & Another** while relying upon its decision in **B.S. Joshi's case (supra)** has also held that in view of the compromise

arrived at between the parties, the technicalities should not be allowed to stand in the way in the quashing of criminal proceedings and the continuance of the same after compromise between the parties would be a futile exercise.

Similar views were expressed by Hon'ble the Apex Court in **Madan Mohan Abot v. State of Punjab, 2008(4) SCC 582**, the relevant extract of which is as under:-

“ We need to emphasise that it is perhaps advisable that in disputes where the question involved is of a purely personal nature, the court should ordinarily accept the terms of the compromise even in criminal proceedings as keeping the matter alive with no possibility of a result in favour of the prosecution is a luxury which the courts, grossly overburdened as they are, cannot afford and that the time so saved can be utilised in deciding more effective and meaningful litigation. This is a common sense approach to the matter based on ground of realities and bereft of the technicalities of the law. ”

Keeping in view the above settled legal position and taking into account the fact that both the parties have desired to live in peace and harmony and carry on with their lives without any ill will or rancour by resolving their differences and entering into the aforesaid compromise, it is evident that it is a fit case where there is no impediment in the way of the Court to exercise its inherent powers under Section 482 Cr.P.C., for quashing of the FIR in the interest of justice.

Accordingly, the present petition is allowed and the cross case against the petitioners in FIR No. 166, dated 31.12.2001 (**Annexure P-1**) for offences punishable under Sections 326, 324, 323, 452 and 34 of the Indian Penal Code, registered at Police Station Kathunangal, Tehsil and District Amritsar, and all subsequent proceedings arising therefrom, are quashed. The order dated 16.12.2011 (**Annexure P-2**), passed by the Judicial Magistrate First Class, Amritsar, is also set aside.
