JASWANT SINGH, J. (Oral)

Present petition under Section 482 Cr.P.C. is for quashing of FIR No.54 dated 04.03.2010, under Sections 406, 498-A of the Indian Penal Code, registered with Police Station Sadar Ludhiana, District Ludhiana City (**Annexure P-1**) and the subsequent proceedings on the basis of compromise dated 13.04.2015 (**Annexure P-2**) arrived at between the parties.

The marriage was solemnized on 21.04.2008 at Ludhiana as per Sikh rites and ceremonies and subsequently, due to the matrimonial dispute, the aforesaid FIR was lodged by the complainant/respondent No.2-Ram Asra, father of respondent No.3/wife-Rupinder Kaur.

It is stated that a full and final settlement has been arrived and the parties are seeking divorce by mutual consent and the date for recording of the statements at 2nd motion is fixed for 15.10.2015.

It is not in dispute that in the petition for quashing of the FIR filed by the husband and mother-in-law of respondent No.3/wife, a written comprehensive settlement (**P-2**) was arrived at between the parties. In terms of the said compromise, husband and wife had sought a decree of divorce by way of consent.

Vide order dated 17.08.2015, this Court directed the learned Illaqa Magistrate/trial Court to send report with regard to compromise in pursuance of which, a report/letter No. 4353 dated 08.09.2015 has been received from learned Addl. Chief Judicial Magistrate, Ludhiana, which is taken on record as **Mark-A**. It is stated in the report that the complainant party has arrived at a compromise with the petitioners/accused without any undue influence and pressure.

Learned State Counsel, on instructions from ASI Randhir Singh, submits that the challan has been presented.

Hon'ble Supreme Court in **(2003) 4 SCC 675, B.S Joshi & Others Vs. State of Haryana & Another** has made it explicitly clear in para 15 of its judgment that the High Court in exercise of its inherent powers can quash criminal proceedings or FIR or complaint and Section 320 of the Code does not limit or effect the powers under Section 482 of the Code.

A Full Bench of this Court in **Kulwinder Singh and others v. State of Punjab and another, 2007(3) RCR (Criminal) 1052** has held that this Court, in appropriate cases, while exercising powers under Section 482 Cr.P.C., may quash an FIR disclosing the commission of non compoundable offences. The relevant extracts read as under:-

“ The only inevitable conclusion from the above discussion is that there is no statutory bar under the Cr.P.C., which can affect the inherent power of this Court under Section 482. Further, the same cannot be limited to matrimonial cases alone and the Court has the wide power to quash the proceedings even in non-compoundable offences notwithstanding the bar under Section 320 of the Cr.P.C., in order to prevent the abuse of law and to secure the ends of justice. ”

Hon'ble Apex Court in another case in **J.T 2008(9) S.C 192, Nikhil Merchant Vs. Central Bureau of Investigation & Another** while relying upon its decision in **B.S. Joshi's case (supra)** has also held that in view of the compromise arrived at between the parties, the technicalities should not be allowed to stand in the way in the quashing of criminal proceedings and the continuance of the same after compromise between the parties would be a futile exercise.

Similar views were expressed by Hon'ble the Apex Court in **Madan Mohan Abot v. State of Punjab, 2008(4) SCC 582**, the relevant extract of which is as under:-

“ We need to emphasise that it is perhaps advisable that in disputes where the question involved is of a purely personal nature, the court should ordinarily accept the terms of the compromise even in criminal proceedings as keeping the matter alive with no possibility of a result in favour of the prosecution is a luxury which the courts, grossly overburdened as they are, cannot afford and that the time so saved can be utilised in deciding more effective and meaningful litigation. This is a common sense approach to the matter based on ground of realities and bereft of the technicalities of the law. ”

Keeping in view the above settled legal position and taking into account the fact that both the parties have desired to live in peace and harmony and carry on with their lives without any ill will or rancour by resolving their differences and entering into the aforesaid compromise, it is evident that it is a fit case where there is no impediment in the way of the Court to exercise its inherent powers under Section 482 Cr.P.C., for quashing of the FIR in the interest of justice.

Accordingly, the present petition is allowed and FIR No.54 dated 04.03.2010, under Sections 406, 498-A of the Indian Penal Code, registered with Police Station Sadar Ludhiana, District Ludhiana City (**Annexure P-1**) and all subsequent proceedings arising therefrom, are quashed.
