Petitioner has filed this petition under Section 439 of the Code of Criminal Procedure, 1973 seeking regular bail in FIR No.327 dated 27.10.2014 under Sections 307, 450, 147, 148, 149 of the Indian Penal Code, 1860 and Section 25 of the Arms Act, 1959, registered at Police Station City Rewari, District Rewari, Haryana.

Heard.

Petitioner is in custody since 17.12.2014. Challan has already been presented in the Court and conclusion of trial may take time. Although, as per the prosecution case, pistol shots had been fired but none had suffered any fire-arm injury. Co-accused Yogesh has been allowed bail by this Court vide order dated 01.09.2015. Although, there are other criminal cases registered against the petitioner, but in

view of the facts and circumstances of the present case, it would be just and expedient to grant bail to the petitioner.

Accordingly, without expressing any opinion on the merits of the case, this petition is allowed. Petitioner be admitted to bail subject to the satisfaction of Chief Judicial Magistrate, Rewari
