Report dated 19.10.2015 of learned Judicial Magistrate 1st

Class, Sunam has been received whereby after recording statements of complainant Jagsir Singh, LR's of the deceased namely Hari Singh, Mukhtiar Kaur and Rani Kaur as well as the accused namely Gurbaj Singh, the Court has shown its satisfaction that the compromise Ex.PX has been arrived at voluntarily, out of free will of the parties, without any undue influence, coercion or pressure.

Heard.

In the light of the satisfaction shown by the Court, being a pure accident case, together with the fact that compromise will go a

long way in ironing out differences for betterment of future life of the parties and in view of the law laid down in '**Gian Singh v. State of Punjab and another**' 2012(4) RCR (Criminal) 543 and '**Kulwinder Singh and others v. State of Punjab and another**' 2007 (3) RCR (Criminal) 1052, the prayer made in the petition is allowed, proceedings by way of FIR No.129 dated 18.10.2010 registered at Police Station Dirbha, District Sangrur under Sections 304A/279/427 IPC and all consequences arising out of the said FIR qua the petitioner are quashed.

The petition stands allowed in those terms.
