This petition has been filed under Section 438 Cr.P.C. for grant of anticipatory bail to the petitioner in FIR No. 129 dated 28.07.2015, under Section 15 of the NDPS Act, registered at Police Station Daba, District Ludhina.

After arguing for some time, learned counsel for the petitioner states that he does not wish to press this petition but liberty may be granted to the petitioner to surrender before the trial Court and move an application for regular bail and that a direction be also issued to the Court to decide the said application expeditiously.

I find this to be a fair request.

Allowed as prayed for.

Let the petitioner surrender before the trial Court on 27.11.2015 and move an application for regular bail which shall be decided by the Court expeditiously but in any case within five days.

Petition stands disposed of in the above terms.
