Quashing of the FIR No.145 dated 20.09.2014 under
Sections 323, 506, 148, 149 IPC (Section 326 IPC added later on),
registered at Police Station Kulgari, District Ferozepur and cross case
DDR No.28 dated 20.09.2014, under Section 323, 506, 148, 149 IPC
(Section 325 IPC added later on) registered at Police Station Kulgari,
District Ferozepur and consequential proceedings on the basis of

compromise, are being sought.

FIR was registered on a statement made by Prabhjot Singh while the cross case DDR was registered on a statement made by Dimple Sharma.

Now, the matter has been compromised by the parties.

In compliance of the order dated 10.12.2014, status report has been received from the District & Sessions Judge, Ferozepur and the statements of the parties have been recorded that they have compromised the matter and have no objection if the present FIR and a cross case DDR is quashed.

Consequently, in view of the status report and in view of the judgment of the Hon'ble Supreme Court in the case of **Madan Mohan Abbot vs. State of Punjab 2008(2) RCR (Criminal) 429**, the law laid down by the Full Bench of this Court in the case of **Kulwinder Singh and Ors. vs. State of Punjab and another 2007(3) RCR (Crl.) 1052**, no useful purpose would be served in prolonging the litigation.

Accordingly, FIR No.145 dated 20.09.2014 under Sections 323, 506, 148, 149 IPC (Section 326 IPC added later on), registered at Police Station Kulgari, District Ferozepur and cross case DDR No.28 dated 20.09.2014, under Section 323, 506, 148, 149 IPC (Section 325 IPC added later on) registered at Police Station Kulgari, District Ferozepur, are quashed with all consequential proceedings arising therefrom qua petitioners.

The petitions stand disposed of qua petitioners.
