Petitioners claim that they have married against the wishes of their parents on 07.2.2015. The photographs of the marriage have been placed on file as Annexure-P-4. The true copy of Secondary Examination Certificate of partial achievement, showing the date of birth of petitioner No.1 and the true copy of Aadhar Card, showing the date of birth of petitioner No.2, have been placed on file as Annexures-P-1 and P-2. The marriage certificate has been placed on file as Annexure-P-3.

It is claimed that the petitioners have moved an application dated 07.2.2015 (Annexure-P-5) before the Superintendents of Police, Panipat and Jind, for protecting their life and liberty as they apprehend danger to their life from the private respondents.

In these circumstances, petition is disposed of with a direction to the Superintendents of Police, Panipat and Jind, to consider the application of the petitioners dated 07.2.2015 (Annexure-P-5) and assess the threat perception and if it is found that there is danger to the life of the petitioners, necessary steps be taken to protect the life and liberty of the petitioners.

However, it is made clear that this order shall not be taken to be the proof of valid marriage.

Disposed of accordingly.
