Prayer in this petition filed under Section 482 CrPC is for protection of life and liberty of the petitioner and respondents no.5 to 9 at the hands of respondent-police officials.

Pursuant to notice issued by this Court, reply by way of affidavit of Varinderjit Singh, PPS, DSP, Chamkaur Sahib, District Roopnagar, on behalf of respondents no.1 to 4, has been filed, wherein it is submitted that on receipt of the complaint, as submitted by the petitioner, the same was marked to Superintendent of Police (Investigation), Rupnagar for enquiry.

The petitioner while appearing before the Enquiry Officer has deposed that there was some misunderstanding and she does not want any action on her complaint. She has also submitted that she does not have any objection if the complaint in question is filed.

In support of his contention, learned State counsel has drawn my attention to the statement of the petitioner – Pinky Chaggar (Annexure R-1/T), which reads as under:-

“Statement of Pinky Chaggar age 35 years, wife of Kulwant Singh, Caste Jatt, resident of # 35, Darpan Enclave, Morinda, Distt. Rupnagar.

Stated that I am resident of above said address and I am working in NDTV. The writ petition filed by me before the Hon’ble High Court against ASI Harbhajan Singh and ASI Ravinder Singh and I do not want any action on the said petition. Now I am also satisfied about my complaint moved by me to Inspector General and Deputy Inspector General. I do not want any action upon those complaints. The above said complaints be filed in the office. I have filed writ petition against ASI Harbhajan Singh and now, he has been transferred to District Mohali. I am going to withdraw my writ petition. I am satisfied now. I have got recorded my statement.

In view of the aforesaid statement and the reply submitted by the respondents-State, no further action is required in the case in hand.

Accordingly, the present petition is ordered to be dismissed as infructuous.
