This petition has been filed under Article 226 of the Constitution of India read with Section 482 Cr.P.C. for issuance of direction to respondent Nos.1 and 2 for granting emergency parole to the petitioner for a period of 30 days.

In pursuance of order dated 30.11.2015, passed by this Court, the matter was inquired into and the learned State counsel, on instructions, states that the fact that the marriage of brother of the petitioner is fixed for 05.12.2015 is found to be correct. There is nothing on record that the petitioner ever misused the concession of bail/parole.

Heard.

Considering the fact that the marriage of the brother of the petitioner is fixed for 05.12.2015 and being a brother he has to arrange the marriage ceremony, the petitioner is ordered to be released on parole, for a

period of four weeks from the date of his release, as per the Rules, on furnishing bonds to the satisfaction of the Chief Judicial Magistrate/Duty Magistrate, Bathinda.

The petitioner shall surrender before the jail authorities after expiry of four weeks, on the date and time to be indicated by the releasing authority at the time of his release.
