SURYA KANT, J (ORAL)

The petitioner is a resident of village Phoolka, Tehsil and Distt. Sirsa. His grievance is against the formation of wards of his village as according him, firstly the objections were not invited by giving adequate publicity in the village and secondly his objections submitted in May, 2015 have not been considered.

2. The Deputy Commissioner, Sirsa has filed reply-affidavit, explaining that in deference to State Government's notification dated 10.12.2014 for effecting wardbandi of all the villages in the State of Haryana, he issued a letter dated 20.01.2015 to all the Tehsildars in District Sirsa to carry out the work of wardbandi as per the following schedule:

6.	<i>As per Rule 4 (9) of Haryana Panchayati Raj Election Rules, 1994, the final publication of the list of wards.</i>	25.02.2015

3. It is further averred that the proposed wardbandi of village Phoolka was published on 04.02.2015 and opportunity was given to the inhabitants of the village Phoolka to submit their objections upto 07.02.2015. Final wardbandi was published on 25.02.2015.

4. The petitioner himself has averred in para 4 of the writ petition that he came to know about the wardbandi in the first week of May 2015 and then submitted the objections alongwith one Jagdish on 04.05.2015.

5. In our considered view, the petitioner having missed the bus in the matter of submission of objections within the stipulated period, the authorities have rightly ignored such belated objections, if any filed by him. The petitioner has also failed to disclose as to what serious prejudice has been caused to him.
