This order shall dispose of three petitions bearing **CWP No.14698 of 2015** titled as **“Gyan Sarovar Vidya Mandir Sr. Sec. School Vs. The State of Haryana”** [for short ‘1st petition], **CWP No.15092 of 2015** titled as **“M.D. Vidya Niketan High School and others Vs. State of Haryana and others”** [for short ‘2nd petition] and **CWP No.15151 of 2015** titled as **“Ideal Private Schools Association (Regd.) Vs. State of Haryana”** [for short ‘3rd petition].
