Instant writ petition has been filed under Articles 226/227 of the Constitution of India for issuance of a writ in the nature of mandamus directing the respondents to grant the benefit of promotional increment(s) to the petitioner in view of circular dated 23.04.1990 (Annexure P/1).

Learned counsel for the petitioner submits that the petitioner has already moved a legal notice dated 01.09.2014 (Annexure P/3), but no action has been taken thereon. Learned counsel confines his prayer for a direction to the respondents to decide his legal notice in view of judgment of this Court passed in CWP No. 7538 of 2014 – Tarsem Lal vs. Punjab State Power Corporation Ltd. and others, decided on 04.02.2015 (Annexure P/10).

Having heard learned counsel for the petitioner and after perusing the paper-book, however, without commenting on merits of the case and without giving notice to the respondents, instant writ petition is disposed of with a direction to the respondents, to look into the grievance of the petitioner specifically made in the legal notice (Annexure P/3) and pass a speaking order in the light of judgment (Annexure P/10). Needful shall be done within a period of three months from the date of receipt of certified copy of this order and copy of the order so passed shall be communicated to the petitioner forthwith.
