This order shall dispose of above mentioned eight writ petitions as the common questions of law and facts are involved therein.

Learned Senior counsel for the University has placed on record a copy of the decision dated 18.08.2015 of the Executive Council of the Indira Gandhi University, Meerpur, Rewari. After considering the enquiry report submitted by Sh. Sudhir Rajpal, IAS, regarding selection/appointment of Professor/Associate Professor/ Assistant Professor and other academic staff at Indira Gandhi, University, Meerpur Rewari, the Executive Council agreed with the

findings of the enquiry that the entire selection process was severely compromised. It was resolved to cancel all selection proceedings (currently kept in sealed envelopes) of various selection committees constituted by the erstwhile Vice Chancellor. Executive Council also was of the view that a fresh selection process be initiated immediately on the basis of the criteria already approved by it.

In view of the above, the writ petitions have become infructuous.

Ordered accordingly.

Needless to add that the petitioners would have a right to challenge the decision of the Executive Council cancelling the selection.

Learned Sr. counsel for the petitioners expressed apprehension that the enquiry report based on which the selections have been cancelled would not be made available to them and before that the fresh selection may be finalized depriving them of the opportunity to challenge the decision of the Executive Council cancelling the selection.

Learned Senior Counsel for the University states that if any of the petitioners applies for obtaining the copy of the enquiry report, the same would be furnished to him within 10 days, thereafter.
