Instant writ petition has been filed under Articles 226/227 of the Constitution of India for issuance of a writ in the nature of mandamus directing the respondents to release the interest on the delayed payment of pension, gratuity and commutation amounting to Rs. 12 lacs to the petitioner.

Learned counsel for the petitioner submits that the petitioner has already moved a legal notice dated 30.11.2014 (Annexure P/6), but no action has been taken thereon. Learned counsel confines his prayer for a direction to the respondents to decide his legal notice (Annexure P/6) within a time-framed period.

Having heard learned counsel for the petitioner and after

perusing the paper-book, however, without commenting on merits of the case and without giving notice to the respondents, instant writ petition is disposed of with a direction to the respondents, to look into the grievance of the petitioner specifically made in the legal notice (Annexure P/6) and pass a speaking order in accordance with law. Needful shall be done within a period of three months from the date of receipt of certified copy of this order and copy of the order so passed shall be communicated to the petitioner forthwith.
